

**4th ADDENDUM TO CONTRACT FOR SERVICES  
BY INDEPENDENT CONTRACTOR**

THIS 4th ADDENDUM is to that Contract for Services entered into on 13<sup>th</sup> January 2013 and as amended by the First Addendum on 15<sup>th</sup> May 2018; by the Second Addendum on 2<sup>nd</sup> February 2021; and by the Third Addendum on June 2021; by and between the County of Siskiyou (“County”) and Karpel Solutions Inc. (“Contractor”) and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the parties desire to extend the term of the Contract;

WHEREAS, the cost of services to be provided under the contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the contract.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Section 8.0 MASTER TERMS AND CONDITIONS; 13.0 CONTRACT TERM shall be extended to June 30, 2027.
