- 1) **Project Information:** RapidHIT ID Machine
- 2) **Primary Location:** 305 Butte Street, Yreka CA 96097
- 3) **Summary:** The RAPIDHIT ID instrument analyzes DNA samples in 90 minutes for rapid comparison. This can be conducted within a lab environment or at a scene to include natural disasters like wildfires. Rapid DNA has many uses ranging from unknown decedent identification to crime scene lead generation.

 - e. **Why is this project a priority for California's 1st Congressional District?** This technology would aid in bringing closure and justice to the community members of the underfunded rural communities within the district. Butte County is the only county within the district to have a Rapid DNA instrument. They currently have an ANDE Rapid DNA instrument which is a competitor to RAPIDHIT ID. The field is moving in the RAPIDHIT ID direction as ANDE has had ethical issues, lost sales representative backing, and has been blacklisted for use within other states. Government agencies including the US Armed Forces have

transitioned to the use of RAPIDHIT ID over ANDE in a continued trend showing the superiority of the RAPIDHIT ID instrument. Without a trusted Rapid DNA instrument, the entire congressional district’s only options for DNA testing is through Bureau of Forensic Services (BFS) laboratories or private forensic labs throughout the country. BFS labs are very selective on the cases and number of samples they will process as backlogs are high and the turnaround time for those cases are lengthy. Private laboratories offer faster turnaround times, but each sample comes with a high price which is taxing on budgets and still longer turnaround times than could be accomplished using the RAPIDHIT ID. The Siskiyou County Sheriff’s Office would be happy to provide Rapid DNA services to municipalities in need within our county as well as offering other counties and jurisdictions within the district to enter a MOU for the services as well. The project should be a priority for California’s 1st congressional district to serve the community members identifying deceased loved ones, responding to natural disasters, and providing investigative leads to identify suspects, keeping the community safer.

- f. **Why is this project a good use of taxpayer funds?** This project is a good use of taxpayer funds as it directly impacts the taxpayer’s safety while also providing closure when it is needed the most. Taxpayers look to law enforcement for answers when loved ones are presumed deceased or missing and this project aids in the speedy identification to give those answers. Taxpayers also assume law enforcement takes every step necessary to keep them safe. Necessary steps to investigate cases means testing items of evidence to identify suspects. The lack of ability to submit evidence in all criminal offenses, the sample limitation on testing cases that are approved, the extended turnaround time, and the extravagant cost of private laboratory testing are all factors that work against our promise to the community members we serve.

Item #2: Nomad Mobile Command Vehicle

- 1) **Project Information:** Nomad Mobile Command Vehicle
- 2) **Primary Location:** 305 Butte Street, Yreka CA 96097
- 3) **Summary:** The response vehicle would allow the safe transport and use of the RAPIDHIT ID instrument to be deployed to scenes within our jurisdiction and respond to various crime scenes in rural areas. The response vehicle includes a generator, sample refrigerator, climate control, but we would need to add satellite, and remote communication capabilities. Eventually, our hope would be to assist neighboring agencies with requests for support.
Using a mobile command center for law enforcement offers many benefits. They provide a centralized location for communication and coordination. Officers at the scene can securely communicate with each other in real time. This promotes efficient decision making and quick response times, essential during critical incidents. Major incidents also generate enormous amounts of data, including information from surveillance cameras, drones, and radio traffic. A mobile command center offers the ability to receive, process, and share all this data on site. As a result, many law enforcement agencies are deploying them in small, and large-scale events.
