

**FOURTH ADDENDUM TO CONTRACT FOR SERVICES**

(4<sup>th</sup> Addendum to extend the term for the Tulelake Solid Waste/Recycling Facility  
Operation Agreement)

THIS FOURTH ADDENDUM is to that Operations Agreement entered into on April 16, 2017 and as amended on May 1, 2018 and as amended on May 21, 2019 and as amended on March 17, 2022 by and between the County of Siskiyou (“County”) and City of Tulelake (“City”) and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the Agreement will expire on the 30<sup>th</sup> day of June 2024 and services continued to be required after that date; and

WHEREAS, the parties desire to extend the term of the Agreement for five additional years and;

WHEREAS, the Parties desire to increase the amount of compensation payable under the Agreement due to the rising cost of labor and insurance;

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Section 3.0 of the Operation Agreement, Term, shall be amended to extend the term of the Agreement through the 30<sup>th</sup> day of June, 2029, unless terminated earlier in accordance with Sections 18.0 or 19.0, to allow both parties to be operating in a full fiscal year;

Section 15.0 of the Operation Agreement, Contract Price/Payment Procedures, shall be amended to provide that:

Paragraph A, Contract Price, shall be amended to add the following compensation:

Each subsequent year the contract price shall escalate at a rate of 3% as follows:

FY 24/25: A total of \$56,804.43 shall be paid in eleven monthly payments of \$4,733.71 and one monthly payment to be \$4,733.62.

FY 25/26: A total of \$58,508.56 shall be paid in eleven monthly payments of \$4,875.71 and one monthly payment to be \$4875.75.

FY 26/27: A total of \$60,263.82 shall be paid in eleven monthly payments of \$5,021.98 and one monthly payment to be \$5,022.04.

FY 27/28: A total of \$62,071.73 shall be paid in eleven monthly payments of \$5,172.64 and one monthly payment to be \$5,172.69.

FY 28/29: A total of \$63,933.89 shall be paid in eleven monthly payments of \$5,327.82 and one monthly payment to be \$5,327.87.

For a total Agreement price not to exceed \$667,896.74 for the term of the Agreement.

All other terms and conditions of the Agreement shall remain in full force and effect.
