11th ADDENDUM TO CONTRACT FOR SERVICES (11th Addendum to extend the term for the Operation of the Happy Camp Transfer Station Contract)

THIS ELEVENTH ADDENDUM is to that Contract for Services entered into on May 14th, 1996 and as amended on July 23rd, 1996, November 12th, 1996, May 25th 1997 August 19th, 1997, March 20th, 2001, June 8th, 2004, May 16th, 2006, July 7th, 2015, July 5th, 2016, June 20th, 2017, August 7th, 2018 and September 3rd, 2019 by and between the County of Siskiyou ("County") and George Chambers ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the Contract will expire on June 30, 2024 and services continued to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract;

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 2 of the Contract for Services shall be amended to extend the term of the Contract through the 30th day of June 2025.

Paragraph 13 of the Contract, Compensation, shall be amended to add an additional One Hundred Twenty Six Thousand Eight Hundred Thirteen Dollars and Ninety-One cents (\$126,813.91), to increase the compensation payable under the Contract to an amount not to exceed \$2,629,658.10 (Two Million Six Hundred Twenty Nine Thousand Six Hundred Fifty Eight dollars Ten cents). Total Compensation payable under this Contract shall not to exceed Two Million Six Hundred Twenty Nine Thousand Six Hundred Fifty Eight dollars and Ten cents. (\$2,629,658.10).

FY 24/25: A total of \$126,813.91 shall be paid in eleven monthly payments of \$10,567.82 and one monthly payment to be \$10,567.89

All other terms and conditions of the Contract shall remain in full force and effect.
