

**THIRD ADDENDUM TO CONTRACT FOR SERVICES  
BY INDEPENDENT CONTRACTOR**

THIS THIRD ADDENDUM is to that Contract for Services entered into on March 3, 2020 and as amended on April 6, 2021 and March 12, 2024 by and between the County of Siskiyou (“County”) and First 5 Children & Families (“Contractor”) and is entered into on the date signed by all parties to it.

WHEREAS, the Contract expired on June 30, 2024 and services continued to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract; and

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract.

NOW, THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 1.01 of the Contract for Services shall be amended to extend the term of the contract through June 30, 2028.

Paragraph 4.01 of the Contract, Compensation, shall be amended to add an additional Seventy-Two-Thousand-and-Eight-Hundred dollars (\$72,800) to increase the compensation payable under the Contract to an amount not to exceed One-Hundred-Sixty-Three-Thousand-and-Eight-Hundred dollars (\$163,800).

All other terms and conditions of the Contract for Services shall remain in full force and effect.
