

**SIXTH ADDENDUM TO PROFESSIONAL SERVICES AGREEMENT  
(CHANG LITIGATION- SPINELLI, DONALD & NOTT)**

THIS SIXTH ADDENDUM is to that Agreement for Services entered into on December 14, 2022, and as amended on June 22, 2023, and as amended on August 1, 2023, and as amended on February 12, 2024, and as amended on April 3, 2024, and as amended on June 19, 2024, by and between the County of Siskiyou (“County”) and Spinelli, Donald & Nott (“Firm”) and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the cost of services to be provided under the Agreement is expected to exceed the not-to-exceed amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Agreement; and

WHEREAS, the parties desire to amend Exhibit “A” to reflect the current rates of attorneys and staff.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 3 of the Agreement, Legal Fees, shall be amended to add an additional Seventy Five Thousand Dollars (\$75,000.00), to increase the compensation payable under the Agreement to an amount not to exceed Three Hundred Thirty Five Thousand Dollars (\$335,000.00).

Exhibit “A” of the Agreement shall be substituted with the new Exhibit “A” rates, attached hereto and hereby incorporated by reference. These rates shall become effective under the Agreement on May 1, 2024.

All other terms and conditions of the Agreement shall remain in full force and effect.
