

**3rd ADDENDUM TO CONTRACT FOR SERVICES  
BY INDEPENDENT CONTRACTOR**

THIS 3rd ADDENDUM is to that Contract for Services entered into on July 25, 2022, and as amended on June 6, 2023, and June 19, 2024, between the County of Siskiyou ("County") and Michael Brown, MSW, LCSW, a sole proprietor ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract; and

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 4.01 of the Contract, Compensation, shall be amended to add an additional Eight Thousand Dollars and NO/100 (\$8,000.00), FY23/24 to increase by One Thousand Eight Hundred Dollars and NO/100 (\$1,800) from Thirty-Nine Thousand Dollars and NO/100 (\$39,000) to Forty Thousand Eight Hundred Dollars and NO/100 (\$40,800), FY24/25 to increase by Seven Thousand Dollars and NO/100 (\$7,000) from Thirty-Nine Thousand Dollars and NO/100 (\$39,000) to Forty-Six Thousand Dollars and NO/100, to increase the compensation payable under the Contract to Eight Thousand Dollars and NO/100 (\$8,000) from One Hundred Ten Thousand Dollars and NO/100 (\$110,000) to One Hundred Eighteen Thousand Eight Hundred Dollars and NO/100 (\$118,800) to an amount not to exceed One Hundred Eighteen Thousand Eight Hundred Dollars and NO/100 (\$118,800)

All other terms and conditions of the Contract shall remain in full force and effect.
