Good Morning Angela,

Attached is a draft of the redline showing the revisions made to Sections 12 and 13. As for Exhibit A, the amendment template includes the following provision:

*3. Exhibit A of the Agreement shall be amended to delete reference to any anticipated dates of payment of grant funds contained in parentheses therein due to the revisions set forth in this Amendment.*

This language results in the following changes to Exhibit A:

- Sections 1 through 6 of Exhibit A currently remain unchanged, as the first five biannual progress report dates in the amended Section 12(B) are unaffected.
- However, two new biannual progress report dates have been added to the amendment: February 15, 2025, and August 15, 2025.
- Section 7, the final payment amount will now be due within 30 days of the final grant report on 2/15/26, instead of the original date of 2/17/25, aligning with the amended Section 12(e).
