This proposal is to equipment the Sheriff's Special Response Team with important breaching equipment to be used in operations and critical incidents to help supplement fire and rescue in our county.

Detailed Description for this Project

The proposal is for a Hurst brand battery powered Jaws of Life tool (Strongarm LE100) which is specifically designed for Law Enforcement and can assist with opening doors, prying material apart, cutting objects that are obstructing passage such as locks, chains or cables. This item is portable and is able to be utilized in the field and remote areas with minimal effort. The second item is a DeWalt 20V battery powered 4-1/2" angle grinder and accessories. This device is even smaller and easier to use and the parts are easier to replace, however it does present a fire risk and is much noisier. Both tools have similar advantages and disadvantages but both have their place and time for use. Having these two items would increase the teams capabilities and ultimately help keep them and our community more safe. These devices will be utilized during operations conducted by the Siskiyou County Sheriff's Office Special Response Team (SWAT) and can be used during any type of critical incident that occurs within the county such as but not limited to, Plane crashes, vehicle crashes, train crashes, school shooting, barricaded subjects, subjects trapped by natural disasters and more.

The only ways to measure the impact of these tools is to conduct mandatory yearly training and document any use during actual operations to show the direct impact.
