## FIRST ADDENDUM TO PROFESSIONAL SERVICES RETENTION AGREEMENT (SWANSON LAW OFFICE – Specialized Legal Consulting and Advisement Services)

THIS FIRST ADDENDUM is to that Agreement for Services entered into on February 8, 2024, by and between the County of Siskiyou ("County") and SWANSON LAW OFFICE ("Firm") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the Agreement expires on December 31, 2024, and services continue to be required after that date; and

WHEREAS, the parties desire to extend the term of the Agreement; and

WHEREAS, the cost of services to be provided under the Agreement is expected to exceed the amount provided in the Agreement; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Agreement; and

WHEREAS, the Services to be Performed, Exhibit B, needs to be revised.



The first sentence of Paragraph 1 of the Agreement shall be amended to read:

Pursuant to this Agreement, Attorney, upon request of County, through County Counsel, shall provide specialized legal services and advising on matters as assigned by County Counsel, and shall provide representation to the Public Guardian/Conservator.

Paragraph 2 of the Agreement shall be amended to extend the term of the agreement through December 31, 2025.

Paragraph 3 of the Agreement, Legal Fees, shall be amended to add an additional Forty Thousand Dollars (\$40,000.00), to increase the compensation payable under the Agreement to an amount not to exceed Eighty Thousand Dollars (\$80,000.00) for the term of the Agreement.

Exhibit "B", Services to be Performed, shall be deleted and replaced in its entirety with the new Exhibit "B", Services to be Performed, attached hereto and hereby incorporated by reference.

All other terms and conditions of the Agreement shall remain in full force and effect.
