2ND ADDENDUM TO THE MEMORANDUM OF UNDERSTANDING & AGREEMENT TO PROVIDE LAW ENFORCEMENT SERVICES

THIS SECOND ADDENDUM is to that Memorandum of Understanding (MOU) entered into on June 18th, 2019 and amended on December 6th, 2022 by and between the County of Siskiyou, Office of the Sheriff ("County") and City of Dorris ("City") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the MOU expired on June 30th, 2023 and services continued to be required after that date; and

WHEREAS, the parties desire to extend the term of the MOU;

WHEREAS, the cost of services to be provided under the MOU is expected to exceed the amount provided in the MOU; and

WHEREAS, the parties desire to increase the amount of compensation payable under the MOU.

WHEREAS, the County contacts listed in Section 1 and Section 2 of the MOU needs to be updated;

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

- Section 4.A., page 2 of the MOU, shall be amended to extend the term of the Contract through June 30th, 2024.
- 2. Exhibit A-1, Section 3, page 1, shall be amended to add fiscal year 2023-2024.
- 3. Exhibit B, Section 1, page 1, add an additional tota of Two Fundred and Nineteen Thousand Two Hundred Fifty Two Dollars and No Cents (\$219, 252.00), increasing the total compensation payable under the MOU to an amount not to exceed One Million Ninety Six Thousand Two Hundred Sixty Dollars and No Cents (\$1,096,260.00)
