I have also found the staff at GECS to be very responsive to the needs of its students as well as the parents.

I know from talking to staff at GECS that the current building they are in has caused them to have to limit enrollment because they simply do not have the space to grow. The staff is scattered in different locations because the size of their building requires them to use different buildings off site. The site on WA Barr Rd would allow everyone to be in one place which would bring the continuity the staff and students need.

As a parent, I am very appreciative of the option we had in choosing what was the best fit for my highschooler to get an education. I am well ingrained in the Mt Shasta community and have had several conversations with other parents who are considering GECS for their students because of concerns they have with the other public schools in the area. This no doubt is likely a reason why the Mt Shasta Union Superintendent has joined the efforts to oppose this use permit. As a parent I believe having options for our children's education is more important than a public school system having a monopoly over the learning environment. Some students are just better served in different learning environments and GECS has provided numerous parents and students that option.
