

**FIRST ADDENDUM TO CONTRACT FOR SERVICES
BY INDEPENDENT CONTRACTOR**

THIS FIRST ADDENDUM is to that Contract for Services entered into on July 1st, 2023 and as amended on August 1st, 2023 by and between the County of Siskiyou ("County") and M. Peters, Inc. ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract; and

WHEREAS, the Scope of Service, Exhibit A, needs to be revised to reflect additional duties.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 3.01 of the Contract, Scope of Services, Exhibit "A", shall be deleted and replaced in its entirety with the new Exhibit "A", Scope of Services, attached hereto and hereby incorporated by reference.

Paragraph 4.01 of the Contract, Compensation, shall be amended to add an additional One Hundred Thirty Thousand Dollars and 00/cents (\$130,00.00), to increase the compensation payable under the Contract to an amount not to exceed Five Hundred Fifty Thousand Dollars and 00/cents (\$550,000.00) for the term of the Contract.

All other terms and conditions of the Contract shall remain in full force and effect.

 - all maintenance, fuel, greasing and fluid check will be included
- e) Full time Equipment operator (40 hours per week)
- f) With the option of 2 hours over time at \$150.00 an hour per day
- g) Working day will be Monday-Wednesday, Friday and Saturdays
- h) Closed New Year's Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day and Christmas Day

Any damage made to County property, resulting from poorly operated machinery, will be at operator's cost.
