

**FIRST ADDENDUM TO CONTRACT FOR SERVICES
BY INDEPENDENT CONTRACTOR**

THIS FIRST ADDENDUM is to that Contract for Services entered into on May 3, 2022, by and between the County of Siskiyou ("County") and Community Initiatives for Collective Impact, Corporation ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the Contract will expire on June 30, 2025, and services continue to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract; and

WHEREAS, the Scope of Services, Exhibit A, needs to be deleted and replaced in its entirety to reflect the additional two year term; and

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 1.01 of the Contract, Contract Term, shall be amended to extend the term of the Contract through June 30, 2027.

Paragraph 3.01 of the Contract, Scope of Services, Exhibit "A", shall be deleted and replaced in its entirety with the new Exhibit "A", Scope of Services, attached hereto and hereby incorporated by reference.

Paragraph 4.01 of the Contract, Compensation, shall be amended to add an additional Twenty One Thousand Eight Hundred Forty Dollars (\$21,840.00) for FY 25/26 and Twenty One Thousand Eight Hundred Forty Dollars (\$21,840.00) for FY 26/27, to increase the total compensation payable under the Contract to an amount not to exceed One Hundred Nine Thousand Two Hundred Dollars (\$109,200.00) for the term of the Contract.

All other terms and conditions of the Contract shall remain in full force and effect.
