FIRST ADDENDUM TO CONTRACT FOR SERVICES BY INDEPENDENT CONTRACTOR

THIS FIRST ADDENDUM is to that Contract for Services entered into on April 1st, 2024 and by and between the County of Siskiyou ("County") and VESTRA Resources,Inc. ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the Contract will expire on March 31,2025 and services continued to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract;

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph <u>1.01</u> of the Contract for Services shall be amended to extend the term of the Contract through June 30th 2025.

Paragraph 4.01of the Contract, Compensation, shall be amended to add an additional eight hundred and twenty-two dollars and twenty-five cents (\$ 822.25), to increase the compensation payable under the Contract to an amount not to exceed Fifty-Three Thousand Dollars and Fifty Cents (\$53,000.50).

All other terms and conditions of the Contract shall remain in full force and effect.
