FIRST ADDENDUM TO FUNDING AGREEMENT FOR ENVIRONMENTAL REVIEW COST

THIS FIRST ADDENDUM is to that Funding Agreement For Environmental Review Costs entered into on <u>April 1st 2024</u> and between the County of Siskiyou ("County") and Southern Oregon Ready Mix, LLC ("Party/ Parties") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the cost of services to be provided under the Funding Agreement is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Funding Agreement; and

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Section 5of the Funding Agreement, Deposit, shall be amended to add an additional <u>Eight Hundred and Twenty – Two Dollars and Twenty-Five Cents</u> (\$822.25), to increase the compensation payable under the Contract to an amount not to exceed Fifty-Three Thousand Dollars and Fifty Cents (\$53,000.50).

All other terms and conditions of the Contract shall remain in full force and effect.
