

THIRD ADDENDUM TO CONTRACT FOR SERVICES BY INDEPENDENT CONTRACTOR

THIS THIRD ADDENDUM is to that Contract for Services entered into on June 22nd, 2023 and as amended on May 21st, 2024, and August 28th, 2024 by and between the County of Siskiyou ("County") and Sun Ridge Systems, Inc. ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the Contract expires on August 25th, 2025, the anniversary of software "Go-Live", and services continued to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract;

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Exhibit D, attached hereto, shall establish the cost of annual software maintenance and support fees through **August 25th, 2026**.

Exhibit B of the Contract, Contract Amount, shall be amended to add an additional FIFTY-FOUR THOUSAND FOUR HUNDRED SEVENTY-SEVEN DOLLARS AND NO CENTS (\$54,477.00), to increase the compensation payable under the Contract to an amount not to exceed SEVEN HUNDRED TWO THOUSAND THIRTY-EIGHT DOLLARS AND NO CENTS (\$702,038.00).

All other terms and conditions of the Contract shall remain in full force and effect.
