

**1ST ADDENDUM TO CONTRACT FOR SERVICES  
BY INDEPENDENT CONTRACTOR**

THIS 1<sup>st</sup> ADDENDUM is to that Contract for Services entered into on 6/24/2022 by and between the County of Siskiyou ("County") and Canon Solutions Copier Lease ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract; and

WHEREAS, the parties desire to change the name of the Contractor to be reflected as "*Canon U.S.A., Inc.*" under the Contract;

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Accounting Section of the Contract, Compensation, shall be amended to add an additional TWO THOUSAND THREE HUNDRED NINETY SIX DOLLARS AND NO/100 (\$2,396.00) to FY 24/25, TWO THOUSAND FOUR HUNDRED THIRTY NINE DOLLARS AND NO/100 (\$2,439.00) to FY 25/26 and TWO THOUSAND FOUR HUNDRED EIGHTY TWO DOLLARS AND NO/100 (\$2,482.00) to FY 26/27 to increase the compensation payable under the Contract by SEVEN THOUSAND THREE HUNDRED SEVENTEEN DOLLARS AND NO/100 (\$7,317.00) for the total compensation amount not to exceed NINETY FIVE THOUSAND FIVE HUNDRED EIGHTY THREE and NO/100 (\$95,583.00).

All other terms and conditions of the Contract shall remain in full force and effect.
