

**1st ADDENDUM TO CONTRACT FOR SERVICES
BY INDEPENDENT CONTRACTOR**

THIS 1st ADDENDUM is to that Contract for Services entered into on July 13, 2023, between the County of Siskiyou ("County") and John Lessley, Quality Innovations, a Sole Proprietor ("Contractor") and is entered into on the date signed by all parties to it.

WHEREAS, the Contract expires on June 30, 2025, and services continued to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract; and

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract; and

WHEREAS, the Scope of Service, Exhibit A, needs to be revised to reflect additional duties; and

WHEREAS, the General Liability minimum coverage has increased in the Contract in Section 5.06; and

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract.

NOW, THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 1.01 of the Contract for Services shall be amended to extend the term of the contract through June 30, 2027.

Paragraph 3.01 of the Contract, Scope of Services, Exhibit "A", shall be deleted and replaced in its entirety with the new Exhibit "A", Scope of Services, attached hereto and hereby incorporated by reference.

Paragraph 4.01 of the Contract, Compensation, shall be amended to add an additional Thirty-Five Thousand Dollars and No/100 Cents (\$35,000) to increase the total compensation under the Contract to an amount not to exceed Fifty Five Thousand Dollars and No/100 Cents (\$55,000)."

Paragraph 5.06 of the Contract, General Liability insurance, shall increase from \$1,000,000.00 to \$2,000,000.00.

All other terms and conditions of the Contract for Services shall remain in full force and effect.

Exhibit "A"

I. Scope of Services

- a. Review Siskiyou County Behavioral Health Division's most recent Implementation Plan and provide recommendations for updated language to meet the requirements of California Code of Regulations, Title 9, Section 1810.310.
- b. Review Siskiyou County Behavioral Health Division's policies and procedures that must be in accordance with the current Medi-Cal specialty mental health services triennial compliance protocol and make recommendations for improvement. When requested by the Behavioral Health Director or Quality Improvement Coordinator, draft revised policies and procedures.
- c. Advise the Behavioral Health Division Director and Quality Improvement Coordinator about best practices to ensure the Behavioral Health Division is in ongoing compliance with requirements contained in the Medi-Cal specialty mental health services triennial compliance protocol.
- d. Review and make recommendations for the Behavioral Health Division's Program Integrity policies and procedures and the Compliance Plan.
- e. Assist the Behavioral Health Division to comply with any new state requirements that are developed based on new federal Medicaid Managed Care regulations issued.
- f. Provide onsite reviews of evidence prepared by the Behavioral Health Division for the Medi-Cal specialty mental health services triennial system review and make recommendations for development and revision of policies, procedures and presentation of other evidence listed under "suggested documentation" and "guidance" in the current review protocol.

II. Compensation

- a. County shall compensate Contractor at the rate of \$130.00 (One Hundred Thirty and no/100 Dollars) per hour for work performed other than on-site.
- b. The rate for on-site work is \$160.00 (One Hundred Sixty and no/100 Dollars) per hour which includes all travel expenses.
- c. Contractor shall submit original detailed monthly invoices with dates and hours worked.
- d. Total compensation shall not exceed Fifty-Five Thousand and no/100 Dollars (\$55,000.00) for the term of the contract.
