SECOND ADDENDUM TO AGREEMENT BY INDEPENDENT VENDOR

THIS SECOND ADDENDUM is to that Application Subscription Agreement for Services entered into on March 7, 2023, and as amended on January 2, 2024, by and between Siskiyou County Health and Human Services Agency/Public Health Division ("Agency") and Champ Software, Inc., ("Vendor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the Agreement expires on June 30, 2025, and services continue to be required after that date; and

WHEREAS, the parties desire to extend the term of the Agreement;

WHEREAS, the cost of services to be provided under the Agreement is expected to exceed the amount provided in the Agreement; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Agreement.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 2, of the Agreement shall be amended to extend the term of the Agreement through April 30, 2028.

Paragraph II D, of the Agreement, Payment, shall be amended to add an additional Forty-One Thousand Two Hundred Ninety-Six Dollars and no/100 cents (\$41,296.00) dollars, to increase the compensation payable under the Agreement to an amount not to exceed One Hundred Four Thousand One Hundred Eighty-Two Dollars and no/100 cents, (\$104,182.00).

Paragraph 4, of the Agreement, Warranty and Indemnity, shall be amended to add clause C, Additional Insured Status, The Agency, its officers, officials, employees, and volunteers are to be covered as insureds on the CGL policy with respect to liability arising out of work or operations performed by or on behalf of Vendor including materials, parts, or equipment furnished in connection with such work or operations. Coverage can be provided by endorsement to the Vendor's insurance (at least as broad as ISO Form CG 20 10 11 85 or if not available, through the addition of both CG 20 10, CG 20 26, CG 20 33, or CG 20 38; and CG 20 37, or 20 40 if a later edition is used).

All other terms and conditions of the Agreement shall remain in full force and effect.
