The Siskiyou County Board of Supervisors will hold a Public Hearing on Tuesday, June 3, 2025, at 9:00 a.m. or as soon thereafter as may be heard, in the Board of Supervisors' Chambers, 311 Fourth Street, Yreka, California on the following item:

## General Plan Amendment, Adoption and Incorporation of the Local Hazard Mitigation Plan into the General Plan (GPA-25-01)

This project is a proposed General Plan Amendment to incorporate the February 2025 Local Hazard Mitigation Plan (LHMP) into the Seismic Safety and Safety Element of the Siskiyou County General Plan. The incorporation of the LHMP into the General Plan is a necessary step for ensuring that Siskiyou County and local cities, agencies, and communities remain eligible for state and federal disaster assistance funding. Failure to incorporate the LHMP into the General Plan will result in the loss of eligibility for state and federal disaster assistance funding. Prior to incorporation into the General Plan, the LHMP must first be adopted by the Board of Supervisors. To view the LHMP in its entirety please visit:

It is anticipated that the project will be exempt from further environmental analysis pursuant to CEQA Guidelines Section 15061(b)(3). The Board of Supervisors will consider the appropriateness of said environmental recommendation based on the record of evidence before them. If substantial evidence has been presented demonstrating a more appropriate environmental determination than the one that has been recommended, the Board of Supervisors may require and/or approve an alternative environmental determination pursuant to the requirements of CEQA.

In addition, a staff report will be available for public review three working days prior to the Board of Supervisors meeting.
