RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SISKIYOU AUTHORIZING THE ACCEPTANCE OF THE ALLOCATION AWARD UNDER THE Standard Agreement Amendment (STD 213) FOR COUNTY OF SISKIYOU

WHEREAS, the State of California, Department of Health and Human Services Agency, California Department of Public Health (CDPH) Tuberculosis Control Branch (TBCB) issued a Notice of Award for July 1, 2025 through June 30, 2026 dated April 11, 2025, for an allocation of \$2,552.00 spending authority through June 30, 2026.

WHEREAS, the Notice relates to the availability of noncompetitive allocation funds under the Standard Agreement Amendment (STD 213) and

WHEREAS, County of Siskiyou ("County") desires to accept the California Department of Public Health (CDPH) Tuberculosis Control Board Local Assistance Funds (TBCB) Program FY 2025-2026 Funding.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors for Siskiyou County does hereby determine and declare as follows:

SECTION 1. That County is hereby authorized and directed to accept the **Tuberculosis Control Board Local Assistance Funds (TBCB) Program FY 2025-2026 Funding** noncompetitive allocation award, as detailed in the Notice, up to the amount authorized.

SECTION 2. That the County Administrator is hereby authorized and directed to act on behalf of the County in connection with the Tuberculosis Control Board Local Assistance Funds (TBCB) Program FY 2025-2026 Funding Award, and to enter into, execute, and deliver any and all documents required or deemed necessary or appropriate to be awarded the Tuberculosis Control Board Local Assistance Funds (TBCB) Program FY 2025-2026 Funding Award, and all amendments thereto (collectively, the Tuberculosis Control Board Local Assistance Funds (TBCB) Program FY 2025-2026 Funding Award Local Assistance Funds (TBCB) Program FY 2025-2026 Funding Award Documents"). SECTION 3. That County shall be subject to the terms and conditions specified in the Tuberculosis Control Board Local Assistance Funds (TBCB) Program FY 2025-2026 Funding Award Documents, and that County will use the award funds in accordance with the Tuberculosis Control Board Local Assistance Funds (TBCB) Program FY 2025-2026 Funding Program requirements, and any other applicable rules or laws.
