## THIRD ADDENDUM TO CONTRACT FOR SERVICES BY INDEPENDENT CONTRACTOR

THIS 3rd ADDENDUM is to that Contract for Services entered into on January 19,2021 and as amended on March17,2022 and June 6<sup>th</sup> 2023 by and between the County of Siskiyou ("County") and Lynn Cottier ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the Contract expires on June 30th, 2025 and the County will continue to need services after that date; and

WHEREAS, the parties desire to extend the term of the Contract;

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract; and

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 5 of the Contract for Services shall be amended to extend the term of the Contract through June 30<sup>th</sup>, 2027.

Paragraph 4A of the Contract, Compensation, shall be amended to add an additional Twenty Thousand and 00/100 dollars (\$20,000.00) for fiscal year 2025-26 and Twenty Thousand and 00/100 dollars (\$20,000.00) for fiscal year 2026-27, to increase the compensation payable under the Contract to an amount not to exceed One Hundred and Forty Five Thousand and 00/100 dollars (\$145,000.00).

Paragraph 4A of the Contract shall be further amended, to increase the hourly rate to One Hundred and Sixty Dollars (\$160.00) per hour, including time spent traveling to and from Red Bluff and Yreka.

Paragraph 3e. shall be added to the Contract, which states that the County shall give notice of any cancellations of hearings via telephone and text, not email.

All other terms and conditions of the Contract shall remain in full force and effect.
