Large Wildland Incident Report

In 2024 Siskiyou County experienced many initial attack wildland incidents and several major wildland fires that significantly impacted the County. 200 initial attack fires were suppressed by fire resources outside of National Forest Boundaries. The Shelly Fire in the Scott Valley burned 15,477 acres and contributed to significant timber loss in and around Scott Valley communities. Although the county did receive significant rain and snow accumulations than in years past, the 2024 fire season continued to be exacerbated by years of drought causing vegetation to be readily available for ignition. Lightning caused ignitions, and Human caused starts combined with winds and readily available fuel moistures created conditions for the rapid spread of unwanted, and uncontrolled wildland fires.

The Shelly Fire began on July 3rd ,2024 at 1327 hours in the Federal Responsibility Area (FRA) of the Klamath National Forest (KNF) to the west of the community of Greenview CA in the Marble Mountain Wilderness, adjacent to SRA lands in the CAL FIRE Siskiyou Unit (SKU). Federal state and Local fire resources quickly responded in an effort to contain and control the Shelly Fire. An Incident Command Post (ICP) was established in the Town of Etna CA. As the fire progressed, it was identified by the KNF the need to activate a Complex Incident Management Team (CIMT 12). As the fire advanced it eventually burned into the Siskiyou Units area of responsibility. This initiated the CAL FIRE Siskiyou Unit to enter into Unified Command with the KNF and CIMT 12. The decision was made early by the CAL FIRE Siskiyou Unit to establish a second base camp at the Siskiyou Golden Fair Grounds, in Yreka CA, allowing logistical support for the incident to be expanded. On July 14th, 2024, The CAL FIRE Siskiyou Unit made the decision to activate California Incident Management Team 6 to help suppress and logistically support CAL FIRE ordered resources for the Shelly fire. California Incident Management Team 6 transitioned on July 15th and entered unified command with Complex Incident Management Team 12 at 1200 hrs. The Shelly fire was 100% contained on 08/06/2024, 34 days after its ignition.

During the Shelly Fire the Siskiyou Unit experienced significant drawdown of available firefighting resources. Siskiyou County Local Government fire resources played an integral role in responding to fires within State, Federal and Local jurisdictions, during this time. The CAL FIRE Siskiyou Unit also experienced several new wildland fires during the Shelly Fire. The largest fires within the SRA during this time was the Bogus Incident located in the Montague area, that started on July 8th, 2024, which grew to 411 acres. The fire burned in brush, and grass in steep and unforgiving terrain making containment challenging. The fire was contained within its first operational period and several days of mop up and securing fire lines ensued in the days following the start of the fire. On July 15th, 2024, the Paradise fire ignited burning 101 acres in mountainous areas between the communities of Montague and Klamath River Community Estates (KRCE). The Paradise Fire was contained within the first operational period and mop up operations and securing fire lines ensued in the days after the containment. The Shelly, Bogus, and Paradise fires required additional County and State resources to help mitigate these incidents including the Siskiyou County Sheriff's Department, County Roads Department, County OES, County Health Department, CHP, and Caltrans. The threat to life, property and environment is an ever-present concern within Siskiyou County.

Subject: Serving the Citizens of Siskiyou County

Honorable members of the Board,

As the appointed Siskiyou County Fire Warden, Department Head for Siskiyou County Service Area No. 4 (CSA-4) and Siskiyou General County Fire (GCF), I perform the duties and expectations in relation to fire incidents, fire protection and fire prevention as required by the Board of Supervisors. I am tasked with providing for a system of fire protection services to all areas of the county by administration of mutual aid agreements, including the Amador plan, and by providing each fire agency with emergency response resources and support when needed in the service of the citizens of Siskiyou County.

CSA-4 provides extended county services for structural fire protection, as well as other fire related services for the protection of life and property outside of cities and existing fire protection districts. CSA-4 encompasses the entire county which includes four "Fire Zones" and four "Hose Companies". The Fire Zones have special tax assessments that generate revenue to provide emergency service for their areas. The Fire Zones include Hammond Ranch, McCloud, Mt. Shasta Vista, and Pleasant Valley. The Hose Companies are donation-based departments that provide emergency services to their areas. The Hose Companies include Hilt, Klamath River, Salmon River, and Seiad Valley.

GCF maintains an inventory of emergency preparedness and response equipment that includes fire engines, mobile air self-contained breathing apparatus trailers, emergency response trailers, a fuels reduction excavator, and brush chippers. These items are used throughout the county in support of emergency incidents, training, fuel reduction projects and special events. The fire engines are often rented by CAL FIRE in support of state fire emergencies which has created an annual revenue source. The revenue generated in fiscal year 24/25 is currently \$845,280.57. A portion of these funds are then reinvested in equipment purchases, maintenance, and replacement to continue equipment rental to the State of California.

The County of Siskiyou provides extended county services of fire protection through a Cooperative Fire Protection Agreement with CAL FIRE outside of the declared fire season (Amador). The agreement funds three firefighter positions and fire station operation costs for the Hornbrook CALFIRE Station. The fire station, fire engine and company officers are provided by CALFIRE. CAL FIRE only bills for actual services rendered, which results in significant savings for the agreement amount annually.

County wide fire and medical dispatch services are provided by CAL FIRE through a Cooperative Agreement. The contract funds two Communication Operator positions which allows the Yreka Interagency Command Center (YICC) to provide 24 hour, wide-awake 9-1-1 service to the public. The YICC is the single 9-1-1 answering point for all fire and medical emergencies within Siskiyou County. The YICC dispatched 11,099 emergency incidents in 2024, with 7,788 emergency incidents on behalf of volunteer fire departments and 555 emergency incidents within CSA-4.

The Siskiyou County Fire Chiefs Association (SCFCA) and respective departments are still very concerned with staffing. While some departments have had increases in the volunteers others have lost members. Retaining trained volunteers is difficult at best, I see our future fire fighters as cadets, we trained them under 18 years of age and when they turned 18 they are good to be fully fledged fire fighters. We need a larger program that all the departments can use.

Here are some of the challenges the Siskiyou County Departments have faced this year.

- 1. 700 sq miles of sphere of influence added to our response areas.
- 2. NFPA requirements like turnouts less than 10 yr old(2 sets)
- 3. Increase in required yearly training, COS has stepped up to provide.
- 4. Requirement for readiness drills, to respond to the forest agencies fires.

We saw lots of requests for engines to respond to incidents throughout the State, we filled them while trying to keep our local staffing adequate. Our equipment was highlighted with age issues and maintenance needed, like oil leaks, tires over 7 years old, its all small stuff but can hold up a strike team for repairs.

We have been working on department consolidation and thought we had one done but a change in personnel put an end to that. Most departments are still training together and responding to each other's incidents.


We had a couple of successes like the repair and upgrade to the County Command radio net, thank you Siskiyou County Supervisors! We have had this system for 30 plus years and it has never worked, hopefully it will when finished. Also the north county departments received new battery powered jaws of life and the south county department should receive handheld radios, again thank you Siskiyou County Supervisors. We also have a couple new Chiefs, Copco-Thomas Bush, Dorris- Warren Smith, McCloud-Trent Vogus, Butte Valley- Brandon Criss, Etna-Clint Whitechurch.

As always the Siskiyou Board of Supervisors are always welcome at our Siskiyou County Chiefs meeting.







Count of Incident Types by Agencies



The Butte Valley Fire Protection District (BTE) was established in 1965. Our coverage area is approximately 33 square miles and has a population of approximately 1000. Our funding sources are from special district taxes, community donations, and our annual BBQ fundraiser.

We have one station and three volunteer firefighters. Our apparatus includes: one 3500-gallon Water Tender (1988), one Type-1 Engine (1984), one Type-3 Engine (2003), and one Type-6 Engine (1996).

The Board meets the first Tuesday of every month and training is scheduled for the third Tuesday of every month. Training consists of some controlled burns and we also train with CAL FIRE in the summer, we have completed about 80 hours of training this year. Our main goal to accomplish in the upcoming year is active recruitment of new volunteers.

The McCloud Fire Department was established in the early 1990's as part of the McCloud River Lumber Company. In 1965, the McCloud Community Service District (MCU) was established and the responsibility for providing fire services was transferred to the MCSD. Our coverage area is approximately 200 square miles covering from Dead Horse Summit to Snowman's Hill and Harris Mountain to McCloud Reservoir. The population in McCloud is approximately 1,100 people.

Our funding sources are from Special Tax and fundraising. We have one station with a part time Chief, a Recruitment and Retention Officer that is funded through a FEMA SAFER grant, 25 volunteer firefighters, and five auxiliary for a total of 32 personnel. Our apparatus includes: Three Type-1 Engines, 2 Type 3 Engines, a Rescue Squad, an ambulance and 3 Staff vehicles.

The MCSD Board meets the second and fourth Monday of every month. Training is scheduled every Thursday and one Saturday per month. Our goal for the upcoming year is to continue to increase personnel and to provide as much training to our personnel as possible.

The Tulelake Fire Protection District (TUL) was established in 1937. We cover approximately 120-square miles from Hill Road in Siskiyou County to County Road 114 in Modoc County, extending from Stateline Road to Lookout Road to the South. The population is approximately 2234. Our funding source is through property taxes through Siskiyou and Modoc County.

We have two stations - one in Modoc County, and our Main station in Siskiyou County, with 23 Volunteer Firefighters, 2 paid staff, and 1 paid auxiliary, for a total of 26 personnel. Our apparatus includes one Type-1 (2005), two Type-2 (1985, 2001), one Type-3 (2004), one Type-6 (2006), two 4000-gallon water tenders (1971,1997), one 2000-gallon water tender (2007), one 3000-gallon water tender/Type-2 (2018), and one Ambulance/Rescue (2007).

The Board meets every second Wednesday. Our challenges are recruitment and meeting the training standards set by the State and maintaining equipment in an area of declining population.







Currently the District is 18 square miles in size, with a population of 1800 citizens with 544 residents. South Yreka Fire Protection District has one station at 3420 Easy Street, Yreka, California 96097. Yreka City limits are ½ mile north of the station with HWY 3 and Interstate 5 flowing through the District. Our Insurance Rating Service (ISO) is an 8b. The elevation in the District is at 2600 feet to 4000 feet.

All structures within the district are less than 5 miles from the station. There are 7+ commercial structures that are required to meet the California Fire Marshall fire flow. South Yreka Fire Protection District meets the rural level of service (MSR2004). This level is arrival to fire incident within 15 minutes and water flow of 500 gpm. The population per mile is 100; South Yreka Fire Protection has a workload rating of 147.

The District's responsibility is for all improvements and rescue responses. However all Wildland within the district is State Responsibility (SRA). The District does respond to all Wildland fires to assist CAL FIRE. All of South Yreka Fire Protection District responses are dispatched through Siskiyou CAL FIRE dispatch center, which is a 24 hr. staffed center. All equipment has a 500+ channel two-way radio installed and all Volunteers have assigned pagers and handheld radios. All South Yreka Fire Fighters meet the SB 1207 training requirements and receive 4 hr. of training every week.

South Yreka Fire Protection District equipment; Advantage 2004 Type 1 engine with a 1500gpm pump and 2000 gallons of water, KME 1996 Type 1 engine with a 1500 gpm pump and 500 gallons of water, E-One 1995 Type 1 engine with a 1500 gpm pump and 500 gallons of water, Peterbuilt 2021 Water Tender 3600 gallons of water, International 2004 Type 3, 4x4 with a 500 gpm pump and 500 gallon of water, International 1996 Type 3, 4x4 with a 500 GPM pump and tank of water, Ford 550 4x4 rescue with 300 gpm pump and 260 gallons of water, rescue tools, Chevy 3500 4x4 type 6 engine with 300 gal of water. All equipment is in great shape with professional maintenance done. All Equipment is in service and ready to respond at all times and weather.

Total calls for SYR is around 300 call each year for all calls including Mutual aid and automatic aid calls. The workload for calls will not change because we respond currently to all the expanded area calls, what will change is the reporting for the calls and our Assistance for hire to CAL FIRE will go to a 4 hour no charge (mutual aid) from a 2 hour no charge. Also the residents within the expanded area will get credit for living with in a fire district so they can apply for Insurance and a competitive rate. As it stands now many do not have home owners insurance at all or they are paying 4x as much.

The plan for the District is to build a station at the intersection of Cram Gulch rd and Guys Gulch rd. We will have a Type I engine, a Type 3 engine and a Water tender, 400gallon of water and a Rescue with 300 gallons of water., There are already Volunteers that live close by where the station will be built.



The Klamath River Fire Company (KLR) was established in 1984. Our coverage area is Hwy 263 and Hwy 96 to the east of Seiad Valley and seven miles north and south of Hwy 96. The population of our coverage areas is approximately 460. Our funding sources are through various fundraising and donations; Taco Tuesday, Siskiyou Golden Fair Parking, Cowboy Poetry (every other year) and strike teams are our biggest source of income.

We have two stations with 11 volunteer firefighters and 8 Auxiliary members, for a total of 17 personnel. Our apparatus includes: one 1500-gallon Water Tender (1995), four Type-3's (1985,1987,1988 and 2004), and two Type-2 engines (1995 and 1998).

The Board meets every third Tuesday with trainings every Tuesday evening. Multi-Agency, neighboring departments, county and college trainings happen periodically throughout the year. We have put in many hours of training, meetings and fundraising. Our goals for the upcoming year is to maintain funding, increase recruitment, and replace aging equipment.

The McKinney Fire in 2022 created a major set back with the loss of over 200 homes and outbuildings in our community. Our local community is pulling together to rebuild, and we are in the beginning phases 1 and 2 (clean up) in the recovery process. There has been a long term recovery group started and it seems to be well supported by residents. We see progress in clean up of the affected properties and the Highway 96 corridor. My hope is that all of us can work together to help protect our communities from these devastating fires that terrorize our communities.

We currently have 20 Volunteers, 3 paid staff, and Auxiliary Volunteers in the Dalmatians. Our apparatus includes one 250 gallon pump trailer, three 3000 gallon water tenders (1998, 1998, 2000), one 3500 gallon water tender (1993), one 2000 gallon water tender (2000), one Type-1 engines (1998), two Type-2 engines (1994, 2002), three Type-3 engines (1987, 1988, 1994), and one Rescue Vehicle (2012).

Board meetings are the second Tuesday of every month. Training is scheduled for the second and fourth Tuesdays of each month.
