

SECOND ADDENDUM TO CONTRACT FOR SERVICES BY INDEPENDENT CONTRACTOR

THIS SECOND ADDENDUM is to that Contract for Services entered into on October 1, 2022, and as amended on September 21, 2023, by and between the County of Siskiyou ("County") and Dana Kent Krone ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the subcontractor has changed her name to Dana Kent Krone;

WHEREAS, the Contract expires on September 30, 2025, and services continue to be required after that date;

WHEREAS, the parties desire to extend the term of the Contract;

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract.

WHEREAS, the California Department of Public Health added Exhibit D, Special Terms and conditions;

In Process

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 1.01 of the Contract for Services shall be amended to extend the term of the Contract through September 30, 2028.

Paragraph 3.01 of the Contract, Scope of Services, Exhibit "A", shall be deleted and replaced in its entirety with the new Exhibit "A", Scope of Services, attached hereto and hereby incorporated by reference.

Paragraph 3.01 of the Contract, Scope of Services, Exhibit "B" Administrative Policies and Practices (California WPPM #130-10), shall be added in its entirety, attached hereto and hereby incorporated by reference.

Paragraph 3.01 of the Contract, Scope of Services, Exhibit "C" Nutritional Risks Criteria and Descriptions, (California WPPM #960-01) shall be added in its entirety, attached hereto and hereby incorporated by reference.

Paragraph 3.01 of the Contract, Scope of Services, Exhibit “D” Special Terms and Conditions (in accordance with HSC 38070), shall be added in its entirety, attached hereto and hereby incorporated by reference.

Paragraph 3.01 of the Contract, Scope of Services, Exhibit “E” Coordinator for Nutrition Education, (California WPPM #400-09) shall be added in its entirety, attached hereto and hereby incorporated by reference.

Paragraph 4.01 of the Contract, Compensation, shall be amended to add an additional One Hundred Twenty-Seven Thousand Two Hundred Dollars and No/100 cents (\$127,200.00), to increase the compensation payable under the Contract to an amount not to exceed One Hundred Eighty-Three Thousand Three Hundred Sixty Dollars and No/100 cents (\$183,360.00), for the term of the Contract.

All other terms and conditions of the Contract shall remain in full force and effect.
