RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SISKIYOU  
AUTHORIZING THE ACCEPTANCE OF THE ALLOCATION AWARD UNDER THE  
PARTNERSHIP HEALTHPLAN OF CALIFORNIA COMMUNITY HEALTH  
ASSESSMENTS (“CHA”) AND COMMUNITY HEALTH IMPROVEMENT PLAN  
(“CHIP”) DEVELOPMENT SUPPORT GRANT PROGRAM FOR SISKIYOU COUNTY

WHEREAS, Partnership HealthPlan of California announced a grant funding opportunity and issued a Request for Application (RFA) to the 24 counties within Partnership’s network of Local Public Health Departments to support development of CHA and CHIP. The purpose of the grant is to enhance Local Health Jurisdictions’ (LHJ) ability to identify needs and strengths within their communities to reduce siloed approaches to population health management, and aligning where possible with the DHCS Quality Strategy to include their Bold Goals. The one-time allocation is per county, up to \$100,000.00 to be used during the three year period of July 2025 through June 2028. The funding is eligible to roll over annually within the three year cycle. Funding is intended solely for CHA/CHIP development, planning, coordination, stakeholder engagement and documentation.

WHEREAS, County of Siskiyou (“County”) desires to accept the noncompetitive Partnership HealthPlan Grant Funding for the CHA/CHIP program for the period of July 2025 through June 2028.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors for Siskiyou County does hereby determine and declare as follows:

SECTION 1. That County is hereby authorized and directed to accept the noncompetitive CHA/CHIP Development Support Program allocation award, as detailed in the Notice, up to the amount authorized.

SECTION 2. That the County Administrator is hereby authorized and directed to act on behalf of the County in connection with the CHA/CHIP Development Support Program Funding Award, and to enter into, execute, and deliver any and all documents required or deemed necessary or appropriate to be awarded the CHA/CHIP

Development Support Program Funding Award, and all amendments thereto (collectively, the "CHA/CHIP Development Support Program Funding Award Documents").

SECTION 3. That County shall be subject to the terms and conditions specified in the CHA/CHIP Development Support Program Funding Award Documents, and that County will use the award funds in accordance with the CHA/CHIP Development Support Program Funding requirements, and any other applicable rules or laws.
