

**FIRST ADDENDUM TO CONTRACT FOR SERVICES
BY INDEPENDENT CONTRACTOR**

THIS FIRST ADDENDUM is to that Contract for Services entered into on January 7, 2020, by and between the County of Siskiyou ("County") and Diamond Drugs, Inc. dba Diamond Pharmacy Services ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the Contract expires on June 30, 2023 and services continue to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract;

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract.

WHEREAS, the Scope of Services, Attachment "A", shall be deleted and replaced in its entirety with the new Attachment "A", Scope of Services, attached hereto and hereby incorporated by reference.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 6 of the Contract for Services shall be amended to extend the term of the Contract through June 30, 2028.

Paragraph 3 of the Contract, Facility Responsibilities and Paragraph 2 of Attachment A, Compensation, shall be amended to add an additional Four Hundred Sixty Thousand Dollars and No/100 cents (\$460,000.00), to increase the compensation payable under the Contract to an amount not to exceed Seven Hundred Seventy Eight Thousand Five Hundred Dollars and No/100 cents (\$778,500.00). Compensation shall be paid in a not-to-exceed amounts annually of Ninety Two Thousand Dollars and No/100 cents (\$92,000.00) for FY 23/24; Ninety Two Thousand Dollars and No/100 cents (\$92,000.00) for FY 24/25; Ninety Two Thousand Dollars and No/100 cents (\$92,000.00) for FY 25/26; Ninety Two Thousand Dollars and No/100 cents (\$92,000.00) for FY 26/27; and Ninety Two Thousand Dollars and No/100 cents (\$92,000.00) for FY 27/28.

Paragraph 16, of the Contract, Scope of Agreement, Attachment "A", shall be deleted and replaced in its entirety with the new Attachment "A", Scope of Agreement, attached hereto and hereby incorporated by reference.

All other terms and conditions of the Contract shall remain in full force and effect.
