3RD ADDENDUM TO THE MEMORANDUM OF UNDERSTANDING & AGREEMENT TO PROVIDE DISPATCH & RECORDS SERVICES

THIS THIRD ADDENDUM is to that Memorandum of Understanding (MOU) entered into on August 6thth, 2019 and amended on November 14th, 2022 and May 23rd, 2024 by and between the County of Siskiyou, Office of the Sheriff ("County") and City of Tulelake ("City") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the MOU expired on June 30th, 2024 and services continued to be required after that date and

WHEREAS, the parties desire to extend the term of the MOU;

WHEREAS, the cost of services to be provided under the MOU is expected to exceed the amount provided in the MOU; and

WHEREAS, the parties desire to increase the amount of compensation payable under the MOU.

WHEREAS, the County contacts listed in Section 1 and Section 2 of the MOU needs to be updated;

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

- Section 4.A., page 2 of the MOU, shall be amended to extend the term of the Contract through June 30th, 2025.
- 2. Section 4.A in the MOU, on page 2, shall be amended to add fiscal year 2024-2025.
- 3. Add an additional total of Nine Thousand Eight Hundred and Eighty Eight Dollars and No Cents (\$9,880.00) as outlined in Exhibit A, Section 2, page 7; increasing the total compensation payable under the MOU to an amount not to exceed Fifty Nine Thousand Two Hundred Eighty Dollars and No Cents (\$59,280.00).
