

**FIRST ADDENDUM TO CONTRACT FOR SERVICES  
BY INDEPENDENT CONTRACTOR**

THIS FIRST ADDENDUM is to that Contract for Services entered into on June 20<sup>th</sup>, 2025 by and between the County of Siskiyou ("County") and Flock Group, Inc ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract; and

WHEREAS, the County requires the Contractor to name the County on policies identified in Exhibit C.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Exhibit A of the Contract, identified as "Standard Implementation Fee", shall be amended to add an additional TWO THOUSAND FOUR HUNDRED DOLLARS AND NO CENTS **(\$2,400.00)** in accordance with Section 10.3, to increase the compensation payable under the Contract, to an amount not to exceed EIGHTY SIX THOUSAND EIGHT HUNDRED SIXTY DOLLARS AND NO CENTS **(\$86,860.00)**.

Exhibit C shall be amended to add that the County, its officers, agents, and employees will be named as additional insured under the vendors liability policies.

All other terms and conditions of the Contract shall remain in full force and effect.
