## SECOND AMENDMENT TO THE JOINT EXERCISE OF POWERS AGREEMENT FOR THE MODOC SISKIYOU COMMUNITY ACTION AGENCY BOARD

This Second Amendment to the Joint Exercise of Powers Agreement for the Modoc Siskiyou Community Action Agency Board (hereinafter referred to as "Amendment") is by and between the County of Modoc, a political subdivision of the State of California, and the County of Siskiyou, a political subdivision of the State of California and shall be effective January 1, 2011.

## **RECITALS**

- A. The existing Joint Exercise of Powers Agreement by and between the County of Modoc and the County of Siskiyou terminated on December 31, 2010 as outlined in Section 16, Term, of the Joint Exercise of Powers Agreement.
- B. It is the intent of the County of Modoc and the County of Siskiyou to continue the Joint Exercise of Powers Agreement for the Modoc Siskiyou Community Action Agency Board ("JPA").

NOW, THEREFORE, it is agreed between the parties as follows:

- 1. <u>Recitals</u>. The Recitals set forth above are incorporated in this Amendment as if set forth in full herein.
- 2. <u>Amendment</u>. Section 16 of the JPA shall be deleted in its entirety and the following language shall now control:
  - "Term: Unless terminated pursuant to the provisions of Section 17, the term of this agreement shall be from January 1, 2011 through December 31, 2013.
- 3. Entire Agreement. All other terms and conditions of the JPA shall remain in full force and effect.
