

**SECOND ADDENDUM TO CONTRACT FOR SERVICES
BY INDEPENDENT CONTRACTOR**

THIS SECOND ADDENDUM is to that Contract for Services entered into on May 19, 2022, and as amended on June 30, 2025, by and between the County of Siskiyou ("County") and Lawrence & Associates, Inc. ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract; and

WHEREAS, the Exhibit "A" Cover letter, needs to be repealed and replaced to reflect additional duties; and

WHEREAS, the "Attachment C" to the Exhibit "A" needs to be repealed and replaced with a new Attachment "C";and

WHEREAS, the Attachment "E" to the Exhibit "A" needs to be repealed and replaced with a new Attachment "E".

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 3.01 of the Contract, Specific Services, Exhibit "A", Cover Letter, shall be repealed and replaced with the new Exhibit "A" attached hereto.

Paragraph 3.01 of the Contract, Specific Services, Exhibit "A", Scope of Services, shall be amended to repeal the -"Attachment C" to the Exhibit "A" and replace it with the new Attachment "C" attached hereto.

Paragraph 3.01 of the Contract, Specific Services, Exhibit "A", Scope of Services, shall be amended to repeal the -"Attachment E" to the Exhibit "A" and replace it with the new Attachment "E" attached hereto.

Paragraph 4.01 of the Contract, Compensation, shall be amended to revise the amount to be One hundred twenty-six thousand two hundred seventy eight dollars (\$126,278.00) for FY 25/26, One hundred fifty-six thousand seven hundred twenty-two dollars (\$156,722.00) for FY 26/27, and One hundred forty-eight thousand six hundred forty-four dollars (\$148,644.00) for FY 27/28, for a total amount of Four hundred thirty-one thousand six hundred forty-four dollars (\$431,644.00), increasing the total compensation

payable under the Contract to an amount not to exceed Six hundred eighty-two thousand six hundred thirty-eight dollars (\$682,638.00) for the term of the Contract.

All other terms and conditions of the Contract shall remain in full force and effect.


