

**SECOND ADDENDUM TO CONTRACT FOR SERVICES  
BY INDEPENDENT CONTRACTOR**

THIS SECOND ADDENDUM is to that Contract for Services entered into on January 9, 2025, and as amended on July 2, 2025, by and between the County of Siskiyou ("County") and Canon U.S.A. Inc. ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract; and

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Compensation shall be amended to add an additional ONE THOUSAND SEVEN HUNDRED FORTY-FIVE DOLLARS and 82/CENTS (\$1,745.82), to increase the total compensation under the Contract to an amount not to exceed ONE HUNDRED NINETY-FIVE THOUSAND SEVEN HUNDRED TWENTY-FIVE DOLLARS and 88/CENTS (\$195,725.88).

All other terms and conditions of the Contract shall remain in full force and effect.
