Subject: Siskiyou County Board of Supervisors Opposes SB 1327 - Weights and Measures: Electric Vehicle Supply Equipment: State Authority

Dear Senator Reyes,

The Siskiyou County Board of Supervisors respectfully submits this letter in opposition to SB 1327, which would transfer regulatory authority over Electric Vehicle Supply Equipment (EVSE) from the Department of Food and Agriculture and the existing county weights and measures system to the State Energy Resources Conservation and Development Commission.

Siskiyou County supports maintaining the current weights and measures framework that ensures consistent and uniform standards for measurement in commercial transactions across California. This system is grounded in a long-established model of state standards implemented by trained county sealers, ensuring technical expertise and accountability at the local level.

County weights and measures officials play an important role in ensuring accuracy, consumer protection, and equity in the marketplace, including emerging technologies such as EVSE. The existing structure provides consistent application of standards while allowing for responsiveness to local conditions across diverse regions of the state.

There is no clear need to remove EVSE from this established regulatory framework or to transfer oversight to a new state entity. Doing so would fragment a system that is already functioning effectively and is recognized for its expertise and uniform application of standards.

For these reasons, the Siskiyou County Board of Supervisors opposes SB 1327 and urges the Legislature to retain EVSE within the existing weights and measures system that has long served California consumers, businesses, and local governments.
