

**THIRD ADDENDUM TO CONTRACT FOR SERVICES
BY INDEPENDENT CONTRACTOR**

THIS THIRD ADDENDUM is to that Contract for Services entered into on July 10, 2023 and as amended on February 8th, 2024 and on November 20th, 2025 by and between the County of Siskiyou (“County”) and SHN (“Contractor”) and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 4.01 of the Contract, Compensation, shall be amended to add an additional Seventy- Five Thousand Dollars (\$75,000.00), to increase the compensation payable under the Contract to an amount not to exceed One Hundred and Twenty- Five Thousand Dollars (\$125,000.00).

All other terms and conditions of the Contract shall remain in full force and effect.
