PARTICIPATION AGREEMENT AMENDMENT NO. 2
QA/QI Analytics Program ("Program")

This Agreement Amendment No. 2 ("Amendment No. 2") amends Agreement No. 11586-SK-QAQI-25_26 ("Agreement") and Amendment No. 11586-SK-QAQI-25_26-AM1, a contract entered into by and between the California Mental Health Service Authority ("CalMHSA") and Siskiyou County ("Participant") on April 15, 2025. This Amendment shall be effective upon execution by both parties.

This Amendment No.2 hereby amends the Agreement to extend the Term through June 30, 2026, at no additional cost to Participant as described below.

Modifications to Agreement:

1. **Modified Term:** This Amendment No. 2 extends the Term of Program Offerings Nos. 2 – Policies Development, 3- DHCS Compliance Audit Preparation and Response, 4 – Chart Review Tools and Coaching, and 6 – Enhanced Analytics – PHI Dashboards through June 30, 2026, at no additional cost to Participant. The revised Term shall be January 1, 2025, through June 30, 2026.

All other terms or provisions in the Agreement not amended by Amendment No. 2 shall remain in full force and effect.
