Subject/Summary of Issue:

The FAA has approved the Airport Infrastructure Grant (AIG) for Weed Airport for \$555,000 to be used for the installation of a new AWOS with Precipitation Identification (III-P) sensors on new towers and foundations, as well as to support bidding, construction administration, and construction services for the project. The FAA grant will provide 95% of the funding for the project. 4.75% of the project funds will come from a State Match Grant that General Services will apply for after FAA final approval.

General Services hereby requests that the Board of Supervisors ratify the FAA Airport Infrastructure Grant agreement, permission to accept the allocation for \$555,000, and permission to apply for and accept the State Match Grant totaling 4.75% of the project.

Total project is \$555,000; Federal \$527,250; State Match \$26,363; Local Match \$1,387.
