RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF
SISKIYOU AUTHORIZING THE ACCEPTANCE OF THE ALLOCATION AWARD
UNDER THE CALIFORNIA HOME VISITING PROGRAM (CHVP), STATE
GENERAL FUND (SGF) EVIDENCE BASED HOME VISITING (EBHV) FOR STATE
FISCAL YEARS (SFY) 2026-2029, FOR COUNTY OF SISKIYOU

WHEREAS, the State of California, Department of Health and Human Services Agency, California Department of Public Health (CDPH), Maternal, Child and Adolescent Health Division, issued a Notice of Award for Local Health Jurisdictions (LHJ) to award the California Home Visiting Program (CHVP), State General Fund (SGF) Evidence Based Home Visiting (EBHV) for State Fiscal Years (SFY) 2026-2029, to increase the number of families participating in the five EBHV models supported by CDPH/CHVP, and the three continuing EBHV models. The allocation for Siskiyou County is \$534,725 for the period of July 1, 2026 through June 30, 2027, \$534,725 for the period of July 1, 2027 through June 30, 2028, and \$534,725 for the period of July 1, 2028 through June 30, 2029. The total allocation for Siskiyou County is \$1,604,175.00 for the period of July 1, 2026 through June 30, 2029.

WHEREAS, the Notice relates to the availability of funds under the California Home Visiting Program (CHVP), State General Fund (SGF) Evidence Based Home Visiting (EBHV) for State Fiscal Years (SFY) 2026-2029, Funding; and

WHEREAS, County of Siskiyou ("County") desires to accept in the California Home Visiting Program (CHVP), State General Fund (SGF) Evidence Based Home Visiting (EBHV) for State Fiscal Years (SFY) 2026-2029, Funding.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors for Siskiyou County does hereby determine and declare as follows:

SECTION 1. That County is hereby authorized and directed to accept the California Home Visiting Program (CHVP), State General Fund (SGF) Evidence Based Home Visiting (EBHV) for State Fiscal Years (SFY) 2026-2029, Funding Award, as detailed in the Notice, up to the amount authorized.

SECTION 2. That the County Administrator is hereby authorized and directed to act on behalf of the County in connection with the California Home Visiting Program (CHVP), State General Fund (SGF) Evidence Based Home Visiting (EBHV) for State Fiscal Years (SFY) 2026-2029, Funding Award, and to enter into, execute, and deliver any and all documents required or deemed necessary or appropriate to be awarded California Home Visiting Program (CHVP), State General Fund (SGF) Evidence Based Home Visiting (EBHV) for State Fiscal Years (SFY) 2026-2029, Funding Award, and all amendments thereto (collectively, the "California Home Visiting

Program (CHVP), State General Fund (SGF) Evidence Based Home Visiting (EBHV) for State Fiscal Years (SFY) 2026-2029, Funding Award Documents”).

SECTION 3. That County shall be subject to the terms and conditions specified in the California Home Visiting Program (CHVP), State General Fund (SGF) Evidence Based Home Visiting (EBHV) for State Fiscal Year (SFY) 2026-2029, Funding Award Documents, and that County will use the award funds in accordance with all the California Home Visiting Program (CHVP), State General Fund (SGF) Evidence Based Home Visiting (EBHV) for State Fiscal Year (SFY) 2026-2029, Funding Program requirements, and any other applicable rules or laws..
