

FIRST ADDENDUM TO CONTRACT FOR SERVICES BY INDEPENDENT CONTRACTOR

THIS FIRST ADDENDUM is to that Contract for Services entered into on September 1, 2022 by and between the County of Siskiyou ("County") and Ford Aviation Consulting, a Sole Proprietorship, formerly: Ford & Associates, LLC ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the Contract expired on December 31, 2025 and services continued to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract;

WHEREAS, the Scope of Service, Exhibit A and Exhibit B, needs to be revised to reflect additional duties.

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, Workers' Compensation, shall add additional verbiage and provide Exhibit C; Request for Waiver

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 1.01_ of the Contract for Services shall be amended to extend the term of the Contract through June 30, 2029.

Paragraph 3.01 of the Contract, Scope of Services, Exhibit "A" and Exhibit "B", shall be deleted and replaced in its entirety with the new Exhibit "A" and Exhibit "B", Scope of Services, attached hereto and hereby incorporated by reference.

Paragraph 4.01 of the Contract, Compensation, shall be amended to add an additional Seventy Eight Thousand Fifty Dollars and No Cents (\$78,050.00), to increase the compensation payable under the Contract to an amount not to exceed One Hundred Twenty Four Thousand One Hundred Dollars and no cents (\$124,100.00)_.

Paragraph 5.01 of the Contract, Workers' Compensation, shall add: No payment shall be made unless such proof of insurance is provided, unless the County Risk Manager has approved and a waiver of worker's compensation requirements is on file. Contractor is required to obtain Worker's Compensation and notify County if any employee is hired, to verify proof of coverage for any subcontractors, and to hold harmless and defend you in

case of claims arising from failure to provide benefits". Refer to: Exhibit "C" Request for Waiver

All other terms and conditions of the Contract shall remain in full force and effect.
