

Notice of Public Hearing

The Siskiyou County Board of Supervisors will hold a Public Hearing on Tuesday, August 11, 2026, at 9:00 a.m. or as soon thereafter as may be heard, in the Board of Supervisors' Chambers, 311 Fourth Street, Yreka, California on the following item:

County Authority Regarding Parked and Abandoned Vehicles on Public Roads, Within County Road Rights-of-Way, and on Private Property

The Siskiyou County Community Development Department will provide an informational presentation regarding the County's authority to address parked, stored, abandoned, inoperative, and occupied vehicles located on public roads, elsewhere within County road rights-of-way, and on private property in unincorporated Siskiyou County.

The presentation will explain how the County's authority and available enforcement options vary depending on the vehicle's location, condition, use, and effect on public safety. It will also describe the respective roles and legal limitations of County Code Enforcement, the Siskiyou County Sheriff's Office, the California Highway Patrol, County Public Works, Caltrans, and other responsible agencies.

The purpose of the public hearing is to clarify what actions the County may take—and what actions are outside its authority—when vehicles are parked, stored, abandoned, inoperative, or occupied in these locations. The Board of Supervisors will receive public testimony and may provide direction to staff regarding public information, interagency coordination, potential policies, or other future actions. The Board will not decide any individual enforcement matter during this hearing.

All items presented to the Board of Supervisors during a public hearing, including but not limited to, letters, e-mail, petitions, photos, or maps, become a permanent part of the record and must be submitted to the Clerk of the Board. It is advised that the presenter bring 7 copies of anything presented to the Board and that the presenter create copies in advance for their own records. As a courtesy to the public, Siskiyou County offers teleconference access to the hearing, however, if no member of the Board of Supervisors is attending the hearing via teleconference and disruption, outage, or technical error occurs, the Board reserves the right to discontinue teleconference access and to continue conducting the hearing.

All public records related to an open session item on the agenda, which are not exempt from disclosure pursuant to the California Public Records Act, that are distributed to a majority of the legislative body will be available for public inspection at 311 Fourth Street, Room 201, Yreka CA 96097 at the same time that the public records are distributed or made available to **a majority of** the members of the legislative body. All supporting documentation is available for public review in the office of the Clerk of the Board of Supervisors, located in the Siskiyou County Clerk's Office, 311 Fourth Street, Room 201, Yreka, CA 96097, during regular business hours, 9:00a.m. – 12:00p.m. and 1:00p.m. - 4:00p.m., Monday through Friday.

If you challenge the CEQA determination or the validity of this project in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Board of Supervisors at, or prior to, the public hearing.
