

**1st ADDENDUM TO CONTRACT FOR SERVICES
BY INDEPENDENT CONTRACTOR**

THIS 1st ADDENDUM is to that Contract for Services entered into on September 11, 2025, by and between the County of Siskiyou ("County") and Gary Ernst ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS the parties desire to increase the amount of compensation payable under the Contract; and

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 4.01 of the Contract, Compensation, shall be amended to reflect an increase in the annual amount for FY25/26 by Twelve Thousand Five Hundred Dollars and No/100 cents (\$12,500.00) and add an additional Thirty-Seven Thousand Five Hundred Dollars and No/100 Cents (\$37,500.00) for FY26/27, to increase the compensation payable under the Contract to an amount not to exceed Seventy-Five Thousand Dollars and No/100 Cents (\$75,000.00).

All other terms and conditions of the Contract shall remain in full force and effect.
